## REGULAR FARE INFORMATION

Day passes may be purchased in advance.

Day passes are *not* available on the bus and *must* be purchased at the transit center.

## DISCOUNTED FARE INFORMATION

Passenger must display valid discount card.

Senior Citizen (aged 65 and older) .....	\$ .60
Disabled Citizen .....	\$ .60
Children (5 & under) .....	FREE
Student (grades K-12 & college) .....	\$ .60
Paratransit Service .....	\$2.00
Active Duty Military .....	\$ 1.00

Transfers are free and are valid *only* at the transit center.

After you have paid your fare, please move quickly to a seat. Note the seats marked for seniors or disabled passengers. Please make room for those passengers to board and sit comfortably. Free transfers are available at the Transit Center only. No eating, drinking, or smoking is allowed. Shirts and shoes are required. Service animals only. No fighting, pushing, throwing of objects, loud radios, or vulgar language. Do not talk to the driver when the vehicle is in motion. Strollers must be folded up when boarding the bus. Aisles are to be kept free of obstacles. Children age 12 and under must ride with an adult. Please pull cord before arriving at bus stop location.
